# **Extremely important Business Meeting on Tuesday, August 16, 2016 in the basement of Tiny Tim's at 7:30 PM.**

For the last few months, we have been searching for a solution to allow the Knights of Columbus Council #738 to continue to maintain our presence and fulfill our missions of charity, unity, and fellowship while remaining fiscally sound. In the past, we have

depended upon the surplus in our investment fund to pay for several charitable donations. The recent unrest in the stock market and significant donations has caused this fund to become unavailable. The initial investment was set up to allow us to use any excess over \$245,000.00 to support council programs. Presently, the investment fund has reached this limit and is not available. In the past, we have donated all of the proceeds from our fund raisers to specific needy sources (building funds, charities for people with special needs, Gibault School, and the needs of our parish). The only source of income for the Council has been the collection of dues which is not sufficient to fund the programs we have supported in the past without help from the Investment fund.

After much discussion and research, we have created a Resolution to amend the management of the funds generated from the sale of the Columbian Club property. The Investment Committee feels this resolution is an excellent compromise that seeks to maintain the principal in the investment by providing a procedure that protects against unwise withdrawals by giving the Investment Board greater latitude in working with the investment while providing access to needed funds to support council programs.

We need your vote on this Resolution. The Resolution will be voted on during the Business Meeting on August 16, 2016. If at all possible, please attend and cast your vote on this very important Resolution. We would like to have the approval of the majority of our membership. If you are unable to attend this meeting, please help by sending your Proxy vote in one of three ways. First, please fill in the form below and mail it to Paul W. #### RESOLUTION TO AMEND THE MANAGEMENT OF FUNDS GENERATED FROM THE SALE OF THE COLUMBIAN CLUB PROPERTY

**Whereas:** The Knights of Columbus Council #738 has invested \$245,000.00 from the sale of property held by the Columbian Club Corporation into a permanent fund only to use the interest generated to support council programs, and

**Whereas:** The fund has created a lasting legacy in honor of all Knights who have served this council and is managed by an Investment Board comprised of the Grand Knight, Deputy Grand Knight, and three Trustees, and

**Whereas:** The economic conditions in recent years have not always generated a positive return to fund worthy council programs, and

**Whereas:** Charity is a founding principle of the Knights of Columbus and supporting our church and community has been a hallmark of our organization since its founding.

**Thereby, Let it be Resolved:** That the Investment Board be given greater latitude in choosing conservative investment vehicles that may generate asset value in addition to interest, and

Let it further be Resolved: That in underperforming years, the Knights of Columbus Council #738 can make withdraws not exceeding \$5,000.00 of the principle within a 6 month period from the investment fund to support important council programs. Any withdraw of principal will be granted after approval by the Investment Board and announcement in two consecutive business meetings including an approved motion in the second business meeting, and

Let it further be Resolved: That every effort should be made to minimize withdrawals of the principle to maintain the lasting legacy in honor of past Knights and provide a strong foundation for future Knights of Council #738.

#### PROPOSED AMENDMENT TO THE BY-LAWS OF KNIGHTS OF COLUMBUS COUNCIL 738 AS ADOPTED DECEMBER 4, 2012

We have tried to make our meetings more appealing and productive by introducing speakers, games, and fellowship in our social meetings. This has worked well as our attendance has increased with two meetings having more than 40 guests. This year we will reduce the number of meetings to allow members to have some time for other activities. We have been trying to keep our meetings to between 60 to 90 minutes. This has allowed members to leave before 9:00 PM if necessary. **The following amendment and appropriate calendar will be voted upon at the August 16, 2016 Business Meeting.** 

#### LIST OF PROPOSED MODIFICATIONS AND ADMENDMENTS TO THE BY-LAWS OF VALPARAISO COUNCIL #738 Valparaiso, IN as adopted December 4, 2012

#### Article IV – Meetings Present By-Law:

Section 1. The Council's monthly business meeting shall be held at a date, time and location established by the Council. Ten members shall constitute a quorum at business meetings.

Meetings shall be held on the first and third Tuesday of each month. The first Tuesday shall be a regular business meeting. The third Tuesday on odd months shall be a First Degree except July. The third Tuesday on even months shall be a social meeting.

#### **Proposed Modification of Council By-Laws**

Section 1. The Council's monthly business meeting shall be held at a date, time and location established by the Council. **EIGHT** members shall constitute a quorum at business meetings.

Meetings shall be held on the first and third Tuesday as follows.

- The first Tuesday on even months shall be a social meeting.
- The third Tuesday on even months shall be a regular business meeting.
- The third Tuesday on odd months (except July) shall be a First Degree followed by a brief business meeting as required to conduct council business.
- There will be no meetings in July.
